The meeting was chaired by Jonas Christoffersen, The Danish Institute for Human Rights

1. Welcome

The Chair opened the Assembly. The Chair and the Assembly expressed, with applause, their gratitude to Thomas Gammeltoft-Hansen for his achievements while serving as AHRI chair during his employment at the Danish Institute for Human Rights.

2. Adoption of Agenda

The Chair proposed an additional item no. 11, Utrecht Declaration on Academic Freedom.

Decision: The agenda, as amended, was approved.

3. Approval of Minutes from Assembly Meeting, Belgrade 2015 (Annex 1)

Decision: The minutes were approved.

4. Report of the Chair

The Chair informed the Assembly about the developments since the Assembly 2015, focusing on the following:

- <u>AHRI conference</u>. The Chair commended the Netherlands Institute of Human Rights (SIM) for hosting the excellent 2016 conference in Utrecht.
- 2. <u>Working Groups</u>. The chair summed up the debate in the Executive Committee.
 - a. <u>Education</u>:

Inga Bostad, chair of the Working Group on Education and Teaching, informed the Assembly about a proposal of establishing a MOOC on Human Rights and Migration, to be led by the Norwegian Centre for Human Rights, which will provide staff resources for this initiative. The development will commence in the autumn 2016. An invitation to participate in the initiative will be distributed.

- <u>Visibility strategy</u>. The chairs of the Working Groups of "AHRI as Policy Maker" and "An AHRI journal" will at the next AHRI Conference 2017 present a paper on ways to enhance the visibility of AHRI in the academic world and in policy-making.
- c. <u>Expansion of AHRI membership</u>. A strategy for the expansion will be developed. As part of this work, the legal status of AHRI, as well as amendments of the AHRI Constitution, will also be considered. It is the ambition of the chair to finalise the work on the legal status of AHRI as well as amendments of the Constitution at the AHRI Conference 2017.

Decision: The Assembly approved the report of the Chair.

5. Financial Statement (Annex 2)

The Chair commended the surplus from the 2015 Conference in Belgrade, and urged AHRI members to pay the annual membership fee.

Antoine Buyse informed the Assembly that part of the conference budget for the 2016 Conference had been spent on travel expenses for participants in need of financial support.

Decision: The Financial Statement was approved by the Assembly.

6. Admission of New Members (Annex 3)

The Chair referred to annex 3 and gave representatives of the applying institutions the opportunity to present themselves to the Assembly:

- <u>"Alfredo Vázquez Carrizoza" Institute for Human Rights and Peacebuilding</u> <u>Universidad Javeriana of Bogotá, Bogotá, Colombia</u> Director Manuel E. Salamanca, offered a short presentation of the institute and motivated the membership application.
- 2) <u>Instituto de Democracia y Derechos Humanos de la Pontifica Universidad</u> <u>Católica del Peru, Lima, Peru</u>

Director Elizabeth Salmón offered a short presentation of the institute and motivated the membership application.

- <u>University College Dublin Centre for Human Rights</u>, <u>Dublin</u>, <u>Ireland</u> Director Suzanne Egan was absent with apology. Praise for the centre and its expected valuable contribution was raised by several Assembly participants.
- Human Rights Center, University of Dayton, Dayton, Ohio, USA Director Camilo Perez-Bustillo offered a short presentation of the centre and motivated the membership application.

Member of the Executive Committee, Margot Solomon, mentioned that the Executive Committee, before the next Assembly meeting, would consider a revision of the current requirement that membership applications must be supported by an existing AHRI member. The reason is that the foreseen expansion of AHRI may include the admission of members that are not well known to existing members.

Decision: The four institutions were admitted as members of AHRI and the Assembly took note of the information regarding supporting letters.

7. Election 2017

There are no elections for AHRI bodies in 2016. The chair stated that the secretariat would add a list of elected institutions to the minutes of the meeting in order to secure a common memory of earlier elections. The list is as follows:

Following the timespan for the elected positions, as outlined in the AHRI Constitution, the positions of Chair and Executive Secretary as well as those of four members of the Executive Committee are up for election in 2017.

The Chair recalled that elections are institutional. Institutions and not persons are members of AHRI and the Assembly is made up of the directors of the members.

The Chair further observed that the constitution does not require that the Chair and the Executive Secretary (and the accompanying Secretariat) be based at the same institution. However, the Executive Committee discussed the issue and agreed that it, for practical reasons, would be preferable for the Chair and Executive Secretary to be from the same institution.

One AHRI member has communicated a preliminary expression of interest, but in order to secure and open and transparent process, the Executive Secretary will send out, in September/October, a Call for Expression of Interest for taking over positions of Chair and Executive Secretary (and hence also the Secretariat). Based on the incoming responses, the Executive Committee will make its recommendation to the Assembly in April 2017.

Decision: The Assembly approved the procedure.

8. The AHRI Conference 2017

Professor Jan Wouters gave an update on the conference, which will be hosted by the Leuven Centre for Global Governance Studies and take place in Leuven 27 and 28 April (Annex 6). All participants will be invited to the FRAME conference 26 April. AHRI members interested in joining the Programme Committee are invited to approach Jan Wouters.

Decision: The Assembly received the update.

9. Future Work

The Chair informed the Assembly that one AHRI member has expressed interest in hosting the 2018 Conference, which will have the same format as the 2016 Conference. The procedure for electing the conference host will follow previous years: in September/October 2016 the Executive Secretary will issue a Call for Expression of Interest. Based on incoming Expressions of interests the Executive Committee will choose the host of the AHRI conference 2018. The Committee will aim at electing a host before the end of 2016.

Decision: The Assembly approved the procedure.

10. Next Meeting

The Chair observed that the next Assembly meeting will take place on 28 April 2017 at the conference in Leuven.

11. Utrecht Declaration on Academic Freedom.

A draft Declaration was presented to the Assembly. The draft Declaration was discussed. Members able to translate the Declaration were encouraged to approach the Executive Secretary. All AHRI members were encouraged to disseminate the Declaration as widely as possible. The Executive Committee was recommend to take contact to Scholars at Risk in order to distribute the Declaration and express support for its cause.

Decisions:

- The Assembly adopted the Declaration (Annex 7)
- The Executive Committee will take contact to Scholars at Risk.
